REPRODUCE RECORDS: \$0.10 per page, \$20/hr., \$5 min.

TOWN COMMUNITY CENTER RENTAL: \$125/day = Newbold Residents Plus \$300 deposit
\$250/day = Non-Resident Plus \$300 deposit
Non-profit group= \$100/day plus deposit or \$50/half day (4 hrs. or less)
(deposit returned if clean & no damages)

**TOWN COMMUNITY CENTER-
CONFERENCE ROOM ONLY RENTAL:** \$50/day, maximum 12 persons= Newbold Resident
(plus deposit of \$300) \$100/day, maximum 12 persons= Non-Resident
